Evaluation	Outcome 1 remains highly relevant and should not be changed. The graduate nursing outcomes are aligned with the standards of the Commission on Collegiate Nursing Education (CCNE), the accrediting body for WKU's nursing programs. Many of these outcomes, including Outcome 1, are double or triple-barreled in nature. Outcome 1 states: "Critically appraise theoretical concepts and knowledge from nursing and other disciplines and integrate this evidence in developing, implementing, and evaluating best practices for improved health outcomes." This outcome reflects a foundational principle of advanced nursing practice and aligns well with current healthcare demands and professional standards. Although it is a triple-barreled outcome, it remains clearly measurable through the use of action verbs consistent with Bloom's Taxonomy. Maintaining this outcome supports the program's commitment to preparing graduates who are both competent and responsive to the dynamic needs of the healthcare system.

	All DNP students compile a DNP portfolio organized by the eight DNP essentials which are considered foundational competencies for DNP programs by the American Association of Colleges of Nursing (AACN). The portfolio includes DNP Essential Summary Papers that are a reflective account of the student's DNP experience and how they met each Essential.	
Criteria & Targets	DNP Proposal Paper : Students will score of \geq 160 of 200 pts on the DNP Project Proposal paper completed in NURS 750 (Program Evaluation). In this paper students appraise literature on a problem in health care, develop a purpose for their DNP project, and integrate the

	92% is the current target for this measurement and was appropriate for this measure in the past; however, due to recommended changes from our accrediting body (AACN), Essentials will change to competency model in the future. Evaluation of how to measure the new competency model will occur during the next AY of 25-26.
Results & Conclusion	Results for DNP Project Proposal Paper: 22-23AY = 100% - n = 10/ average score 186 23-24AY = 100% - n=9/average score 184 24-25AY = 100% - n=4/average score 182
	Results for Portfolio – Essential VIII: 22-23AY = 100% -n=11/average score 10.3 23-24AY = 100% - n=9/ average score 10.5 24-25AY = 100% - n=7/ average score 10.6
	Conclusions: The results for DNP Project Paper were slightly lower in 24-25AY than expected, but the decreasing number of DNP students could account for this drop.
	The results for Portfolio – Essential VIII were as expected. This Essential VIII summary remains important as it provides students with an opportunity for reflection and reinforces the DNP Essentials within the context of their overall program learning experience.
**IMPORTANT - Plans for Next Assessment Cycle:	The DNP Project Proposal paper remains an integral component of the overall DNP project process. It is essential for demonstrating student progress within the program and aligns closely with established program outcomes. Results for the DNP Project Proposal paper minimum points of measure for this outcome will be increased to 170 of 200 points instead of 160 in 25-26AY based on the past three year's results.
	The DNP program will be moving away from Essentials and using Competencies in the future per accreditation guidelines (AACN). This measure will be removed or changed for 25-26AY.

Evaluation	Outcome 2 remains highly relevant and should not be changed. The graduate nursing outcomes are aligned with the standards of the Commission on Collegiate Nursing Education (CCNE), the accrediting body for WKU's nursing programs. While many of the outcomes are double or triple-barreled, Outcome 2 is double-barreled and remains measurable, supporting both clarity and effective assessment.

	A target of 92% is well above the average and represents an appropriate and ambitious goal for this program, reflecting its commitment to excellence and high academic standards.
Results & Conclusion	Results for Analysis of Leadership Philosophy Paper 22-23AY = 88% - n=8/score average 134 (one student scored <120) 23-24AY = 100% - n=5/score average 138.2 24-25AY = 100% - n=1/score 129 Results for Interdisciplinary Consultations Clinical Cousework 22-23AY = 94% - n=30/32 documented at least 2 interdisciplinary collaborations 23-24AY = 100% - n=10/10 documented at least 2 interdisciplinary collaborations 24-25AY = 100% - n=12/12 documented at least 2 interdisciplinary collaborations Conclusions:
	The Analysis of Leadership Philosophy Paper results were not as expected in 22-23AY, but have improved since that time. Perhaps the increased emphasis on the importance of leadership at a DNP level assisted in this increase. Lower enrollment numbers are likely to impact or skew results compared to previous years with higher enrollment. This shift will require ongoing monitoring to establish new benchmarks and accurately interpret emerging trends. Interdisciplinary consultations results were exceedingly higher than expected, therefore, identifying the need to increase the expectation
	for this measure from two to eight documented interdisciplinary consults per class (NURS 547, NURS 549, and NURS 554). What worked for this measure was increasing the emphasis on the importance of interdisplinary consults within the courses.
**IMPORTANT - Plans for Next Assessment Cycle:	The Leadership Philosophy Paper is a valuable component of the DNP program and remains an important outcome measure, as it demonstrates students' understanding of leadership principles and styles relevant to advanced nursing practice. It reflects their ability to articulate a personal leadership philosophy aligned with the expectations of doctoral-level nursing leadership.
	Since the Interdisciplinary Consultations target has been exceedingly met the past two years, we will keep the 92% target but increase the amount of interdisciplary consultations clinically documented from 2 per course to 8 per course. Interdisciplinary consultations are essential for Family Nurse Practitioners, as they promote collaboration with other healthcare professionals to support comprehensive, patient-centered care and achieve optimal health outcomes. These consultations remain an effective measure of Outcome 2, reflecting the application of leadership and communication skills in interprofessional practice.

	The Analysis of Systematic Paper results were not as expected as expected and remained consistent.
	Results for Analysis of DNP Portfolio: Essential III Clinical Scholarship and Analytic Methods for EBP Summary Paper were not as expected in 22-23AY. Scores have improved since that time.
**IMPORTANT - Plans for Next Assessment Cycle:	The Analysis of Systematic Review Paper is a valuable component of the DNP program and serves as an important outcome measure. It demonstrates students' understanding of the systematic review process, including the ability to critically evaluate methods, interpret results, and synthesize evidence to inform practice. No changes are planned for this outcome or measure.
	The DNP program will be moving away from Essentials and using Competencies in the future per accreditation guidelines (AACN). This measure will be removed or changed for 25-26AY.

Evaluation	Outcome 4— <i>Use and evaluate information systems and technology to improve decision-making and health outcomes</i> —remains highly relevant and should not be revised. The graduate nursing outcomes align with the Commission on Collegiate Nursing Education (CCNE) standards, the accrediting body for WKU's nursing programs. While many of the graduate nursing outcomes are double or triple barreled, Outcome 4, though double-barreled, remains clearly defined and measurable.

	Conclusions: The results for both measurement instruments aligned with expectations. Although the average scores for the Clinical Experience Paper showed some fluctuation over time, overall performance remained relatively stable and consistent, reflecting sustained student achievement in this area.	
**IMPORTANT - Plans for Next Assessment Cycle:	After reviewing the results for Outcome 4 over the past three years, it appears appropriate to increase the performance benchmarks. Specifically, the target should be raised from 92% to 94% of students scoring 80 points or higher on the Clinical Experience Paper, and from 92% to 94% of students scoring 42 points or higher on the NURS 740 Presentation. Raising these benchmark targets will help ensure continued academic rigor in the DNP program, particularly given the high level of motivation and performance typically demonstrated by doctoral-level students.

Evaluation	Outcome 5 remains highly relevant and should not be changed. The graduate nursing outcomes are aligned with the standards of the Commission on Collegiate Nursing Education (CCNE), the accrediting body for WKU's nursing programs. Although this outcome is multi-barreled, it remains measurable through key assignments, including the Health Policy and Gap Analysis paper and the Analysis of DNP Portfolio – Essential V Summary paper. Both assessment measures are substantial in scope and serve as summative evaluations of the outcome.

	Conclusions: The results of both the Advanced Epidemiology paper and the Quality Improvement Plan paper meet the expectations of doctoral-level work. However, fluctuations in DNP program admissions have impacted our ability to track data consistently, with some academic years showing low or no student submissions.
**IMPORTANT - Plans for Next Assessment Cycle:	The Advanced Epidemiology paper and the Quality Improvement Plan paper are essential components of the DNP program and serve as meaningful outcome measures. Together, they demonstrate students' ability to apply systems thinking; align quality improvement projects with organizational missions; and assess stakeholders, barriers, facilitators, and outcomes using the PDCA model and relevant QI tools. Additionally, students are expected to analyze key epidemiologic content, including disease processes, at-risk populations, prevalence and incidence, natural history, magnitude, screening methods, financial implications, treatment options, and policy considerations. No changes are currently planned for this outcome or its associated measures.

Evaluation	Outcome 7 remains highly relevant and should not be changed. The graduate nursing outcomes align with the Commission on Collegiate Nursing Education (CCNE) standards which is the accrediting body for WKU's nursing programs and most are double or triple barreled. Although this is a double-barreled outcome, it remains clearly measurable through the use of action verbs aligned with Bloom's Taxonomy. Retaining this outcome reinforces the program's commitment to preparing graduates who are both competent and adaptable to the evolving demands of the healthcare system while optimizing patient outcomes.

	Conclusions: First-time pass rates exceeded expectations, demonstrating the effectiveness of the rigorous yet equitable clinical coursework embedded throughout the BSN-to-DNP FNP track. As expected, all BSN to DNP-FNP students completed reflections identifying their assessment of the patient's understanding and engagement in their health care, identified barriers to care, and reviewed the assessment with their clinical preceptor receiving 100% agreement with the assessment. High expectations for thorough clinical documentation are enforced beginning with the first clinical course.
**IMPORTANT - Plans for Next Assessment Cycle:	The FNP certification pass rate remains the gold standard for assessing readiness for safe entry into advanced family nurse practitioner practice and will continue to be used as a key measure. Reflective documentation, an essential component of APRN practice, will likewise remain an ongoing measure.
